

The receipt of bids was closed at 11:00 a.m. local time on 30 June 2021 as per scheduled date and time. Following three (03) bidders who purchased the bidding documents submitted their bids upto the bid closing date and time.

Farah Electric Service, Karachi were found non-responsive, hence, disqualified, the reasons of the disqualification / rejection were announced besides recording the same at Annexure 4 and 5 of the bid evaluation report.

Subsequently, the rates quoted by the bidders were read aloud along with amount of bid security attached by the bidders. Each rate in the comparative statement were confirmed from the original bids by the committee and recommendations were made, which were documented in the Bid Evaluation Report (BER).


