All Three (03) bidders submitted their bids up to the prescribed bid closing date and time.

The samples submitted by the bidders were examined and observed that all the samples were according to the tender requirements subsequently, the bids were opened by the procurement committee and the rates quoted by the bidders were read aloud along with amount of bid security attached by the bidder and each rate in the comparative statement was confirmed from the original bid by the procurement committee and recommendations were made, which were documented in the Bid Evaluation Report (BER).


