It was informed to the forum that Technical Bids were opened on 11 July 2018 for the above said tender, where out of thirteen (13) firms which purchased the bidding documents, eleven (11) bidders submitted their bids. The complete offers of three (03) bidders viz. M/s. Claris Medical, M/s. Hospital Supply Corporation, and M/s. Noor International were technically dis-qualified and not considered for further evaluation, the reasons of the rejection are recorded in the technical evaluation report.


As per the agenda, eight (08) Technically Qualified (complete or partially) offers were taken into consideration by the committee exclusively. Committee decided that item No. 25 "O.T. Table" should be dropped and re-tendered. The rates quoted by the bidders were read aloud along with amount of 2% bid security attached by the bidder. Each rate in the comparative statement was confirmed from the original bid by the committee and recommendations were made, which were documented in the Bid Evaluation Report (BER).



Financial Bids / Proposals of technically qualified bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance. Financial Bids / Proposals found technically disqualified / non-responsive shall be returned un-opened to the respective bidder(s). Accordingly, prior to evaluate bid in depth, preliminary examination of the bids was made by the procurement committee.


