It was informed to the forum that Technical Bids were opened on 29 January 2019 for the above said tender, where out of fifteen (15) firms who purchased the bidding documents, six (06) bidders submitted their bids. The offers of three (03) bidders viz. M/s. Express Security Services (Pvt) Ltd., M/s. M/s. Rapid Security Guards (Pvt) Ltd. and M/s. Saviours Security Services (Pvt) Ltd. were technically dis-qualified and not considered for further evaluation, the reasons of the rejection are recorded in the technical evaluation report.

As per the agenda, three (03) Technically Qualified offers were taken into consideration by the committee exclusively. The rates quoted by the bidders were read aloud along with amount of bid security attached by the bidder. Each rate in the comparative statement was confirmed from the original bid by the committee and recommendations were made, which were documented in the Bid Evaluation Report (BER). It was observed that M/s. Achtung Security (Private) Limited had not quoted the salary rates in accordance with the Labour & Human Resource Department,
