It was witnessed that the samples of the quoted hospital furniture were not submitted by M/s. Medline Technologies (Pvt.) Ltd., which was the mandatory requirement of the bidding documents (Section V). Hence, their offer was rejected by the procurement committee as the quality and standard of the offered products could not be ascertained in absence of the samples of the products.
