MEMORANDUM

In wake of ongoing second wave of COVID-19 pandemic, in pursuance of decision of the National Command and Operation Center (NCOC) and Universities and Boards Department letter No. (ADMIN)/U&B/NCOC/4-39/2020 dated 25.11.2020 regarding the deteriorating situation of Covid-19 in the province, the academic activities in all constituent Colleges / Institutes / Schools under the administrative control of Dow University of Health Sciences shall remain suspended from 26th November 2020 till 10th January, 2021, with the following conditions: -

- i. All Principals / Directors / Heads of all constituent Colleges / Institutes / Schools and Academic Staff are directed to ensure Online Teaching / Distance Learning for students during the above referred period.
- ii. The Services of Dow Diagnostic Research & Reference Laboratory, Dow Institute of Radiology, Dr. Ishrat-ul-Ebad Khan Institute of Blood Diseases, Dow University Hospital, Ojha Campus, Sindh Infectious Diseases Hospital and Research Centre, Dow International Dental Hospital and Ojha Institute of Chest Diseases will remain fully functional.
- iii. All Postgraduate Trainees posted in Dow University Hospital, Ojha Campus and Dr. Ruth K. M Pfau, Civil Hospital, Karachi will remain present on duty as usual.
- vi. All the Examinations are hereby postponed till mid of January, 2021, subject to improvement in the pandemic situation.
- v. The Office of Principal Officers with a minimum required administrative staff & offices providing essential services shall remain opened with their essential / technical staff. It is intimated to all employees that cell phones must be kept "ON" for proper coordination purpose.
- vi. Further information / direction will be communicated accordingly.
