## NOTIFICATION

In pursuance of Home Department, Government of Sindh vide Order No. SOJI/8-1(04)2020(Stage-4 NPIs) dated 30.07.2021 read with Universities & Boards Department, Government of Sindh Notification No. SO(U)U&B/Misc/23-135/2020/ dated 30.07.2021, it is notified for compliance to all concerned that all Constituent / Affiliated Institutions under the administrative control of Dow University of Health Sciences shall remain closed from 31.07.2021 to 08.08.2021, with the following conditions: -

- i. All Principals / Directors / Heads of all Constituent / Affiliated Colleges / Institutes / Schools and Academic Staff are directed to ensure Online Teaching / Distance Learning with essential faculty and staff for students during the aforesaid period.
  - ii.   - iii. Dental OPDs will continue to provide emergency services at DIKIOHS, DIDC and DDC with complete observance of Covid-19 SOPs.
  - iv. All Postgraduate Trainees and House Officers posted in Dow University Hospital, Ojha Campus and Dr. Ruth K. M Pfau, Civil Hospital, Karachi will remain present on duty as usual.
  - v. All scheduled examinations are postponed. New schedule of the examination will be announced later.
  - vi. The Head of Constituent / Affiliated Institution / Department / Directorate / Section will ensure essential staff working under their administrative control during the aforesaid period.
  - vii. It is intimated to all employees that cell phones must be kept "ON" for proper coordination.
  - viii. Further information / direction will be communicated accordingly.
